- 2. If the child's name has previously appeared on another person's passport then that passport must be produced.
- 3. **Recommendation of Application:** The application must be recommended in Section 6 by a citizen of Kenya, such as a Minister of Religion, a Medical or Legal Practitioner, an established Civil Servant or Bank Official personally acquainted with the applicant.
- 5. Documentary evidence must be produced to support claims to citizenship status.
- 6. The mother or any other person claiming, during the lifetime of the father, to be the legal guardian must produce the Court Order committing the child to her or that person's custody.
- 7. Kenya birth certificates may be obtained from the Registrar-General, PO Box 30031, Nairobi or Assistant Registrar, PO Box 80366, Mombasa.
